#### **Website Terms and Conditions**

#### 1. About the Website

- 1.1. Welcome to www.hertrails.com (Website). The Website provides you with an opportunity to browse and purchase a variety of online programs (Programs) that and physical products (Products) have been listed for sale through the Website. The Website additionally offers you the opportunity to browse Her Trail's services. The Website provides this service by way of granting you access to the content on the Website (Purchase Services).
- 1.2. The Website is operated by Her Trails Pty Ltd (ACN: 660 616 795) (Her Trails). Access to and use of the Website, or any of its associated Programs, Products or services, is provided by Her Trails. Please read these terms and conditions (Terms) carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.
- 1.3. Her Trails reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Her Trails updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication.

## 2. Acceptance of the Terms

You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Her Trails in the user interface.

### 3. Purchase Policy

3.1. In using the Purchase Services to purchase the Programs, Products or services through the Website, you will agree to the payment of the purchase price listed on the Website (**Purchase Price**).

- 3.2. Payment of the Purchase Price may be made through debit card and credit card through the available payment provider (**Payment Gateway Providers**).
- 3.3. In using the Purchase Services, you warrant that you have familiarised yourself with, and agree to be bound by, the applicable Terms and Conditions of Use, Privacy Policy and other relevant legal documentation provided by the Payment Gateway Providers.
- 3.4. Following payment of the Purchase Price being confirmed by Her Trails, you will be issued with a receipt to confirm that the payment has been received and Her Trails may record your purchase details for future use.
- 3.5. You acknowledge and agree that where a request for the payment of the Purchase Price is returned or denied, for whatever reason, by your financial institution or is unpaid by you for any other reason, then you are liable for any costs, including banking fees and charges, associated with the Purchase Price.
- 3.6. Unless otherwise stated, all amounts are listed in Australian Dollars (AUD) and are GST exclusive, being goods and services tax as defined in A New Tax System (Goods and Services Tax) Act 1999, exclusive amounts. Where the services are provided outside Australia, GST is inapplicable.
- 3.7. If you are making payment under a payment plan, and any payment under the Terms is not made in full on the due date, Her Trails is entitled to charge you interest at the rate of 4.5% per annum, calculated daily.
- 3.8. You agree that if you default on any payments due and payable under the Terms, any costs incurred by Her Trails for steps taken to enforce payment terms will be recoverable and payable by you.
- 3.9. Her Trails does not provide refunds for Products, Programs or services. Please keep this in mind when making a purchase.

## 4. Delivery of Programs and Licence Information

- 4.1. Each Program purchase grants you access to the Program through the available platform (**Member Portal**).
- 4.2. When you purchase a Program through the Website, Her Trails grants you a limited, revocable, non-exclusive, non-sublicensable, non-transferable license to access and

- use the specific Program and any related software, content, equipment or other materials for your specific, non-commercial use only (**Licence**).
- 4.3. The Licence is valid for the Program term outlined on the Program information page of the relevant Program (**Licence Term**). This means the Program will be viewable via the download link for the Licence Term only. After this time the Program will expire and You will no longer be able to access the Program.
- 4.4. The Programs are intended for use in a single household within the licence Term only. Sharing of Your Licence is prohibited. This includes the sharing of any supplemental Program materials, digital resources, and access to any other aspect of the Program.

## 5. Program Refunds and Cancellation

You must notify Her Trails of an intention to cancel your involvement in the Program as soon as practicable through e-mail to info@hertrails.com and abide by the following cancellation policy (Cancellation Policy).

## Her Trails 10KM, Her 21.1 Trail, Her Training Cycles and 28 day Grit & Growth Challenge

- (a) Her Trails 10 KM, Her 21.1 Trail, Her Training Cycles and 28 day Grit & Growth Challenge are non-refundable.
- (b) Her Trails will only provide you with a refund of the Purchase Price if Her Trails is unable to continue to provide the programs (the '**Refund**').

### UTA 11KM & 22KM, UTA 50 KM & 100KM, Her Trails 50KM and Her Trails 100KM

- (a) Her Trails understand that individual life circumsntaces change. If you wish to cancel your involvements in any of the UTA 11KM & 22KM, UTA 50 KM & 100KM, Her Trails 50KM and Her Trails 100KM, you must notify Her Trails of an intention to cancel by e-mail to info@hertrails.com and abide by this Cancellation Policy.
- (b) If you cancel your involvement in any of the Programs outlined in clause 10(a) above, you will not received a refund for monies paid up to and including the date of cancellation, and your program membership will be transferred to an alternative program more aligned with your circumsntaces and revised goals.

## 6. Termination of any Program by Her Trails

- (a) Her Trails reserves the right to terminate your involvement in any Program for a breach of these Terms with 7 days' notice by e-mail.
- (b) If Her Trails terminated your involvement in a Program, you agree to pay Her Trails for the portion of services completed up to the date and time of termination.

## 7. Warranty for the Program

- 7.1. Her Trails makes no warranty that the Program will meet your requirements or that all participants will achieve the same results.
- 7.2. The Programs come with guarantees that cannot be excluded under the Australian Consumer Law. For major failures with the Program, you are entitled to cancel your contract with Her Trails, and are entitled to a refund for the unused portion, or to compensation for its reduced value. A major failure with the service is defined by the Australian Consumer Law and includes but is not limited to severe situations where a service is unfit for the purpose it is sold or creates an unsafe situation.

## 8. Program Disclaimer

### 9. Delivery of Products

- 9.1. Her Trails reserves the right to accept or reject your order for any reason, including if the requested Product is not available.
- 9.2. You acknowledge that the Purchase Services offered by Her Trails integrate delivery (Delivery Services) through the use of third-party delivery companies (Delivery Service Providers).
- 9.3. If an item is lost or damaged in the course of the Delivery Services, Her Trails asks that you:
  - (a) contact the Delivery Service Provider directly to request a refund or to claim on any insurance options available; and

(b) contact us by sending an email to info@hertrails.com outlining in what way the Products were damaged in transit so we can determine if the Delivery Service Provider should be removed from the Purchase Services

#### 10. Product Refunds

- 10.1. If you have received the incorrect Product, Her Trails will provide a refund on the return of the Product. To request a refund and organise a return please e-mail info@hertrails.com with your proof of purchase and photographs of the Product you have received within 5 business days of receiving the Product.
- 10.2. Her Trails does not provide refunds for change of mind.
- 10.3. Refunds will not be given for late delivery outside the stipulated delivery time frames provided on the Website or by the delivery service providers.
- 10.4. In the following situations, no refund or return will be available.
  - (a) Denied acceptance of delivery by receiver;
  - (b) Inaccurate delivery address;
  - (c) Absent receiver If a receiver is not home and a calling card is left at the address by the delivery service provider, it is the receiver's responsibility to contact the delivery service provider to arrange appropriate delivery. If the parcel remains undeliverable due to no contact from the receiver, it will be returned to Dr Kristy Goodwin for a return fee charged to the initial payment method.
  - (d) Her Trails wants you to be satisfied with your Product. If you have any issues with Her Trail's Products, please e-mail info@hertrails.com.

## 11. Warranty for Products

The Products come with guarantees that cannot be excluded under the Australian Consumer Law. For major failures with the Product, You are entitled to choose a refund or replacement for major failures. If a failure with the Product does not amount to a major failure, you are entitled to have the failure rectified in a reasonable time. If this is not done you are entitled to a refund for the Product.

Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of Victoria, Australia, without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

# 22. Independent Legal Advice

Both parties confirm and declare that the provisions of the Terms are fair and reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of inequality or bargaining power or general grounds of restraint of trade.

## 23. Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
